The Institute is in receipt of your communication, vide letter no: DBR/WGE/NEIGRIHMS - 4DCT/2019/09; dated: 23.06.2021 and confirmation thereafter, wherein you have indicated your inability to abide by the Public Procurement Order No: 1, 2 & 3, issued vide F.No.6/18/2019 –PPO; dated: 23.07.2020 /24.07.2020, by Ministry of Finance, Department of Expenditure (Public Procurement Division), New Delhi,

It is noted that inspite of several opportunities provided and sufficient time of more than 30 days granted to the e-bidder for compliance to Clause 8, the same was not complied. In view of non compliance at your end to Clause No. 5 & 8 of the Notification of Award and Orders of the Government of India, the Award of Contract is withdrawn forthwith, at your own risk and responsibility.
