

Tender Notice

On behalf of Director, North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences Shillong, Sealed tenders in two bid System are invited from the registered contractors of MePWD/MePHED/MeECL/MES and other equivalent class of CPWD for the following work and will be received at the office of the Executive Engineer (Electrical), NEIGRIHMS upto 1500 hours on 01.02.2016 and will be opened on the same day in the presence of tenderers or their authorized agents at 1530 hours.

Terms and Conditions:-

- The tender is a Two Bid System. All technical & competency documents are to be enclosed in Envelope-1. Only the price bid is to be enclosed in Envelope-2. The Tender Reference and name of work is to be mentioned clearly on each envelope. Intermixing of envelopes will tantamount to rejection. Tender document may be downloaded from NEIGRIHMS website www.neigrihms.gov.in and to be submitted along with the tender document fee of Rs. 500/- only in case these are downloaded from website.
- All pages of tender document are to be signed by the tenderer as a token of acceptance of the terms & conditions failing of which the tender will be rejected.
- EMD to be deposited in the form of deposit at call / fixed deposit from a Scheduled Bank in favour of the Deputy Director, NEIGRIHMS, Shillong.
- Tenderers have to quote their rates both in figure and in words.
- Contractor should be an Electrical Registered contractor with State Govt/Central Govt/MeECL and should have Wireman with valid licence.
- Contractor should submit attested copies of Valid Electrical Contractor Registration Certificate along with recent passport size photograph and attested copies of valid license of wireman.
- Contractors/Firms are to submit experience certificate/documents of similar works.
- Tenderers are required to submit attested copies of sales tax/VAT registration & PAN card.
- All applicable taxes will be deducted at the source. Labour cess @1% shall be deducted from the bill of contractor.
- The contractor shall not sub contract the work to sub-contractors or to any single sub-contractor. An undertaking by the contractor shall have to be submitted to this effect in the enclosed format.
- The bidders shall be deemed to have inspected and examined the site of work, its surrounding before submitting the tenders.
- During the execution of the work, the contractor shall keep the site reasonably free from all unnecessary obstructions and shall store or depose of any of their equipment or surplus materials and clear from the site any wreckage, rubbish or temporary works in consultation with the Sanitary Superintendent of the Institute.
- The contractor while employing labour should ensure that all the statutory labour laws and regulation are adhered to.
- Successful Non-Tribal tenderers should submit the Valid Trading license.
- Average Annual financial turnover during the last three years should be at least 30% of the estimated cost i.e Rs.1,91,227/- only. Tenderer should submit financial statement from Chartered Accountant as per the enclosed FORMAT.
- The defect liability period will be one year from the date of completion of the work.
- The successful contractor shall provide a performance security for his proper performance of the contract within 7 (seven) days from the date of receipt of letter of award. The performance security @ 5% of the contract price shall be in the form Fixed Deposit/Call Deposit to be pledged in favour of Deputy Director (Admn), NEIGRIHMS.
- If the contractor fails to complete the execution of the work as specified in the work order and if extension of time is granted, the contractor shall be bound to pay as liquidated damages a sum of 0.5% per week of delay for such default subject to a maximum of 5% of the contract price.
- The Tenderers are required to furnish an affidavit on a non-judicial stamp paper that there is no police/vigilance/CBI case pending against them.
- The Institute reserves the right to accept or reject any or all tenders without assigning any reasons thereof. All disputes shall be within the jurisdiction of Shillong.
- Parties should have the experience of having successfully completed similar works during the last 7 (seven) years ending last day of month previous to the one in which applications are invited should be either of the following.:(a).Three similar completed works costing not less than the amount equal to 40% of the estimated cost or (b) Two similar completed works costing not less than the amount equal to 50 % of the estimated cost or (c) one similar completed work costing not less than the amount equal to 80 % of the estimated cost. Documentary proof in the form of completion certificates only are to be enclosed failing which the tender will be non responsive.

22. Rates once accepted will not be enhanced due to variation in the rate of materials, labour and Government taxes.
23. No tools and plants will be supplied by the Institute
24. No materials will be supplied by the Institute.
25. While submitting price bids, contractors should not use correction fluid. Price bids where correction fluid has been used will not be accepted.
26. The Party shall be responsible for the safety of all its workmen/employees during the period of execution of the work. The party shall provide all safety materials, gadgets, equipments etc to all its workmen/employees to ensure their safety during execution of the work. The Institute shall not be held responsible in case of any accidents, mishaps etc to the party and its employees
27. Any delay in completion of the works beyond the stipulated date due to reasons attributable to the contractor may eventually lead to cancellation of letter of award for which the contractor is not entitled to any compensation. The cancellation of letter of award would lead to forfeiture of performance security.
28. The contractor is to register with the Labour Department for the work and the registration certificate has to be submitted, failing which the bill cannot be processed
29. If any statutory tax/deduction/recovery is notified by the State/Central Govt, the same shall be deducted from the bill of the contractors as applicable from its effective date of coming into force.
