On behalf of Director, North Eastern Indira Gandhi Regional Institute of Health & Medical Sciences (NEIGRIHMS), Shillong, sealed quotations in two bids system are invited by the Executive Engineer (Electrical), NEIGRIHMS for Supply of one set of Underground Cable Route Tracer from the manufacturers or authorized vendors under the terms & conditions as mentioned below.

Name of item: Underground Cable route tracer

Technical specification:

1. It shall cover the specification for Cable route tracing equipment to be useful for LT cables (440 volt, 1.1 KV, 3.3 KV) & HT cables of 11 KV rating accurately.
2. Depth estimation (0.3 m to 3 m in Power mode).
3. Power mode + Radio mode + Auto mode operation.
4. Frequency/ Mode.
 - a) Power mode 50 H_z or 60 H_z.
 - b) Radio mode 15 KH_z to 60 KH_z.
 - c) Generator mode 8 KH_z and 33 KH_z.
 - d) Auto mode = Power + Radio mode.
5. Protection to be conformed to IP54 & IP65.
6. Battery life: Minimum 40 hours for intermittent use (at 20° C).
7. Operating transmission frequencies 8 KH_z to 33 KH_z.
8. Accessories such as signal clamp, earth spike and cable connection set to be provided.

Terms & Conditions:

1. This tender is a Two Bid System. All technical & competency documents as well as the specification are to be enclosed in Envelope No. 1 Only the price bid is to be enclosed in Envelope No.2. The tender reference with name of work is to be mentioned clearly on each envelope. Intermixing of envelopes will tantamount to rejection.
2. Price quoted should be inclusive of all applicable taxes and levies. It should be both in figure and words. Rates should be F.O.R. Shillong.
3. Delivery should be within 30 days from the date of receipt of order for supply.
4. The supplier shall submit the suitable test certificate to conform the required specifications.
5. The Institute reserves the right to reject any or all quotations without specifying any reasons thereof.
6. In case of delay, penalty at the rate of 0.5 % per day of the ordered value shall be charged (maximum penalty upto 5 % of the order value can be deducted).
7. Rates once submitted cannot be changed and valid for at least one year from the date of contract.
8. The quotation must be quoted duly typed on the letter head of the supplier/ manufacturer duly mentioned full address, VAT No./PAN No. and must be in a sealed cover which should be super scribed Quotation for Supply of Underground Cable route tracer.
9. Payment shall be released after successful completion of supply of the item. TDS as per Income Tax Rules and any other deductions as per Govt. Rules will be made.
10. EMD of Rs.20, 000/- only in form of F.D/B.G. /C.D. pledged in favour of Deputy Director (Admn), NEIGRIHMS, should be enclosed in Envelope No.1
11. Tender fee of Rs. 500/- will be part of the quotation/tender in the form of C.D./D.D. in favour of Deputy Director (Admn), NEIGRIHMS, & should be enclosed in Envelope No.1
