The Grievance Redressal Officer will look after the grievances of the Officer and Staff of the Institute as under:

- 1. Any person aggrieved with the non-compliance of the provisions of Section 20, may file a complaint with the Grievance Redressal Officer, who shall investigate it and shall take up the matter with the establishment for corrective action.
- 2. The Grievance Redressal Officer shall maintain a register of complaints in the matter as may be prescribed by the Central Government, and every complaint shall be inquired within two weeks of its registration.
- 3. If the aggrieved person is not satisfied with the action taken on his or her complaint, he or she may approach the District-Level Committee on disability.
