In partial modification to this Department's circular No. NEIGR-FIN/ACCT-A/08/2019/Pt/216 Dated 24.11.2021 (copy enclosed), it is hereby informed to all concerned employees who are being governed by National Pension System (NPS) that as per the recent email letter Dt. 29.12.2022 from CRA-Protean eGov Technologies Ltd, subscribers will not have a facility to raise Partial Withdrawal request through their system logins as directed by PFRDA vide Circular No. PFRDA/2022/40/ASP-EXIT/04 Dt. 23.12.2022 (copy enclosed).

With effect from 1st Jan, 2023, subscribers desirous of availing partial withdrawal are required to fill up the form (available at https://www.npscra.nsdl.co.in>>Home>Central Government>Forms> Withdrawal Forms) and submit the same to Accounts Section for raising a request in CRA system on behalf of the subscriber.

It may be reminded that employees who are applying partial withdrawal for the purpose of construction of a house or purchase of flat, the requirement of giving prior intimation to the authority for acquiring of immovable properties and seeking previous sanction from the prescribed authority for building of a house, etc under Rule 18 of CCS (Conduct) Rules still continues to apply.

Subject: Partial Withdrawal for NPS Subscribers

PFRDA has issued a circular no: PFRDA/2021/3/SUP-ASP/3 dt.14.01.2021 on partial withdrawals under NPS through self-declaration for the benefit of subscribers as a special dispensation to cope with the Covid pandemic in order to protect the subscribers' interest and ease the burden of nodal officers including POPs from verification and authorization. The circular also provided for the option of submission of the partial withdrawal requests by the subscribers through their nodal office/POPs as per the prevalent practice.

- 2. In terms of the said circular, the online requests of the Subscribers directly processed in CRA system post Instant Bank Acct Verification through penny drop, without the need for the authorization by the associated nodal officers/POPs. It has benefited the subscribers during the Covid pandemic and immobility caused due to lock downs in various parts of the country to contain the spread of corona.
- 3. With the abating of the pandemic-related difficulties & relaxation of lock down restrictions, the issue examined after taking into consideration of the prevalent practices, circumstances and law, it has been decided to make it mandatory for all the Government sector subscribers (Central/ State Govt & Central/State Autonomous Bodies) to submit their requests through their associated nodal offices.
- 4. The subscribers belonging to the voluntary segment of the NPS (All citizens and Corporate) may continue to use the process as mentioned in the cited circular.

The above instructions shall come into effect from 01/01/2023.

Dear Sir / Madam,

Please refer to enclosed PFRDA circular dated December 23, 2022 having the subject 'Partial Withdrawal for NPS Subscribers'.

In this regard, as directed by PFRDA through this circular, effective January 1, 2023, Government Sector subscribers will not have a facility to raise Partial Withdrawal (Also termed Conditional Withdrawal) request through their CRA system logins.

After January 1, 2023, subscriber's desirous of availing partial withdrawal facility, may:

- a. Fill up the form (available on our portal) and submit the same to their DDO/PAO/CDDO for raising a request in CRA system on behalf of the subscriber.
- Once this request is raised, same shall be displayed in CRA system to the oversight PAO / CDDO for final authorization.
- After authorization, the partial withdrawal funds shall be credited to subscriber's registered bank account as per extant settlement timelines.

As of end of day December 31, 2022, any partial withdrawal request raised by the subscriber which is awaiting OTP / eSign, will be auto cancelled to adhere to the contents of aforementioned circular.

Subject: Ease of Partial withdrawal of NPS subscribers through self-declaration - regarding.

In continuation to this Department's circular No. NEIGR-FIN/ACCT-A/08/2019/ Dated 7.6.2021 on the subject mentioned above (copy enclosed), it is hereby informed to all concerned employees who are being governed by National Pension System (NPS) that as per the recent email letter Dt. 11.10.2021 the features as highlighted at para 4 & 5 of PFRDA's Circular No. PFRDA/2021/3/SUP-ASP/3 Dt. 14.1.2021 (copy enclosed) has been made available in the CRA system in the interest of the subscribers.

As per the above stated new features as provided in the Standard Operating Procedure (SOP) for online processing of partial (conditional) withdrawal request by Subscriber at Sr. No. 5 under topic "Initiation of Online Partial Withdrawal request in CRA System by Subscriber", the employees, after initiation and successful submission of online request in the CRA system, are not required to submit the physical withdrawal form and supporting documents to the Nodal Office as the online request is not required to be verified and authorised by Nodal Office.

However, in the case of employees who are unable to initiate online request for any reason, the option of offline mode through submission of Physical Partial Withdrawal Form to Nodal Office for initiation, verification and authorisation is still available.

It may be noted that the requirement for prior intimation to the authority for acquiring of immovable properties and permission from the prescribed authority for building of a house in the case of both online and offline request for partial withdrawal for the purpose of construction of a house or purchase of flat still continue to apply.
