Essential Experience for Professor, Clinical Psychology: i) 12 years standing in profession with teaching & research experience out of which 4 years as Associate Professor in the concerned discipline.

## For Sl. 02: Essential Qualification and Experience for Deputy Director:

Officers under the Central/State government/ Central Autonomous body

Holding analogous posts on regular basis.

OR with five years' service in the grade rendered after appointment thereto on a regular basis in Level 12 or equivalent in the parent cadre/ department.

B. Possessing following educational qualification and experience

- i. A recognized medical qualification included in the 1 or II Schedule or Part II of the third Schedule (Other than licentiate qualifications) to the Indian Medical Council Act of 1956. (3) Desirable: Knowledge of Government rules and regulations.
- For Sl. No. 06: Essential Qualification and Experience for Accounts Officer: Officers from Central/State Governments/ Autonomous organizations/ Research Institutions/ Universities/Statutory Bodies. Holding analogous posts on regular basis, or with 2/3 years regular service in the relevant field in the grade pay of Rs. 4800/4600 respectively and undergone successful training in cash and accounts works in ISTM or have passed Subordinate Accounts service examination.
