



In referring to the Ministry's letter under reference on the subject above, I am directed to submit hereunder the relevant information in respect of NEIGRIHMS, Shillong, for information and necessary action at your end.

- (a) Whether 40% sanctioned medical posts in Central Government –run Hospitals are vacant.

Reply:-In respect of NEIGRIHMS, the percentage of vacant posts as on date is 22% of the sanctioned strength.

- (b) If so, what steps are being taken to fill-in the vacant posts at the earliest and the details thereof.

Reply:- The Institute is making efforts to fill up the remaining vacant posts. The Institute has floated a Rolling advertisement dated 23.11.2022 for filling up 48(forty eight) vacant faculty posts. The interview was also conducted on 20th & 21st June 2023. Another Rolling advertisement to fill up 16(sixteen) vacant faculty posts have already been sent to DAVP, New Delhi to publish the advertisement. The Institute is also issuing Rolling advertisement to fill up the vacant posts of Senior Resident Doctor & Junior Resident Doctors. Apart from these the Institute had also advertised the Group A, posts of Lecturer, Casualty Medical Officer & Deputy Registrar

With regard to B & C posts Institute is making all efforts to fill up the remaining vacant posts. Out of 159(One hundred & fifty nine) vacant group B posts, 38 (thirty eight) selected candidates for the posts are yet to join the posts, 14 (fourteen) posts have already been advertised and screening under process, 78 (seventy eight) posts are to be advertised shortly, 21(twenty one) posts are to be filled up by promotion, 04(four) posts proposed for amendment of existing RR, 04 (four) posts are posts with no approved RR and the approval is still awaited from Ministry.

The Institute is also having a functional hospital with about 29 departments of both specialty and super specialty and bed strength of about 595.

Construction of the Under Graduate Medical College (UGMC) for 100 annual intake alongwith other infrastructure comprising of (i) Regional Cancer Centre with 250 Beds and (ii) Expansion of Nursing College for admission from 50 to 100 annual intake alongwith the Hostel, started in March 2017 is completed by M/s HSCC.



Reply:- The Institute has submitted proposal for upgradation of Pay Scale, Learning Resource Allowance and Academic Allowance on the lines of AIIMS, New Delhi and PGIMER, Chandigarh to the Ministry of Health & Family Welfare, Govt of India, New Delhi as incentive to attract and retain faculty members (copies enclosed).

- (b) The number of Faculty members resigned for the last 3 years.
Reply:- The number of faculty members resigned during the last 3(three) years (2020 to 2022) is 18 (eighteen) numbers.

- (c) Whether the Government is aware of the quality of works doing by the consultancy and contractors, if no, any inspection by Higher Authority to check the quality and standards and

Reply:- As part of Project Implementation and monitoring, Ministry vide F.No. -U-12012/35/2021-NE Dated 16/03/2022 had constitute a High Powered Committee (HPC) with the following composition and with specific Terms of References (TORs) , to Review progress as well as quality of the following projects

1. Setting up of Undergraduate Medical College with hostels
2. Regional Cancer Centre along with patient guest house at NEIGRIHMS, Shillong
3. Expansion of Nursing College with Hostels

The High Powered Committee reviewed the Progress of the Projects on 13th May 2022 , 29th October 2022 and 19th May 2023.

The Progress of the construction works was also reviewed by Chairman Executive Committee Secretary (H) –MOH&FW –GOI on 22nd July 2021 and also Review Meeting of Projects was taken by Secretary (H) MOH&FW on 29.07.2022 , besides Project Review meetings held at level of Joint Secretary (NE) –MOH&FW. Further the progress of the Project was also reported to the 42nd Standing Finance Committee under Chairmanship of Secretary (H) –MOH&FW –GOI on 23rd August 2022. The Project is monitored and reviewed periodically at the Institute level under Chairmanship of Director –NEIGRIHMS along with M/s HSCC and M/s L&T.

Progress and status of the Project was also reported in the last 13th Governing Council of the Institute held on 10.02.2023, under Chairmanship of Hon'ble Union Health Minister –MOH&FW –GOI , held at New Delhi , Nirman Bhavan.

Reply: Project consultant M/s HSCC (I) Ltd appointed by Ministry with a consultancy fee of 5% to take up the following as per the scope of work :-

A. Execution of the work for the following works is taken up by M/s Larsen and Tubro Limited Chennai

1. Setting up of Undergraduate Medical College for 100 intake with 5 –hostels of 500 total capacity
2. Regional Cancer Centre with 252 Beds along with patient guest house of 28 rooms at NEIGRIHMS, Shillong
3. Expansion of Nursing College for increasing the intake from 50 to 100 ,with 2 –Hostels of 310 total capacity and a dining hall of 390 total capacity

B. Execution of the Setting up of Critical Care Hospital Block in NEIGRIHMS under PMABHIM Scheme, is taken up by Ms SPD Construction –Kolkatta.







- (a) Whether the NEIGRIHMS has the status of Institute of National Importance (INI) and if so, the details thereof and if not, the reasons therefor.

Reply: NEIGRIHMS has not yet been accorded the status of Institute of National Importance (INI) at present. However, the Ministry of Health & Family Welfare has initiated a DCN for Introduction of a Bill known as Health Institutions of National Importance Bill, 2023. In this regard the Institute had received an email dated 25.07.2023 from the North East Section of the Ministry wherein it has sought inputs/comments from the Institute on the observations/conditions made by the Ministry of Finance (DoE) in its OM No.3 (63) E. Coord/2023 dated 20.07.2023. Copy of the OM dated 20.07.2023 is at Annexure-I. In response to the email, the Institute has furnished the inputs/comments to Ministry vide letter No. NEIGR-E.II/9/2023 dated 26.07.2023 (Annexure-II).

- (b) Whether the Government proposes to accord INI status to the Institute and if so, the time by which INI status will be accorded for the NEIGRIHMS along with the steps taken in this regard.

Reply: Ministry may like to reply.

- (c) The status of the proposal for cadre review of NEIGRIHMS alongwith the time by which it shall be completed and.

Reply: The 36th Standing Finance Committee held on 31.10.2014 has directed that the rules as followed in AIIMS/PGIMER on Cadre Review may be followed (Annexure-III), which was ratified and noted by the 12th Governing Council held on 26-6-2015 (Annexure-IV).

On similar lines, NEIGRIHMS has initiated the process of internal consultation with all stake holders by a Committee headed by the Deputy Director (Admn) which was also informed and reviewed in the 37th SFC held on 24.2.2016 (Annexure-V). The 1st meeting of the Cadre Review Committee to review cadres of Group 'B' & 'C' of NEIGRIHMS was held on 10th November, 2021 under the Chairperson – Ms. Arti Ahuja, Additional Secretary, Health & Family Welfare, Government of India.

The proposal was discussed at length for 52 cadres of NEIGRIHMS and it was decided to recommend to the DGHS to constitute a Committee of Medical Specialist to develop staffing norms for various specialists, general departments, nurses and other para medical staff in medical institutes/hospitals.

The Committee observed that there was upgradation in the scales and therefore the proposal has to be financial neutral and suggested the Institute that the proposal should be supported with matching savings elsewhere, the cadre structure should be pyramidal to give promotion opportunities to all. The pay scale and hierarchy proposed should be in conformity with the pay scales for similar posts in central hospitals like Safdarjung etc.

The Minutes of the Cadre Review Committee to review cadres of Group 'B' & 'C' posts of NEIGRIHMS held on 10th November, 2021 was issued by Ministry vide F.No.U.12012/33/2019-NE dated 29th November, 2021 (Annexure-VII) and directed the Institute to take immediate action as per the deliberations of the meeting.

The comments from the Heads of Department/Section pertaining to 21 cadres with regard to the proposed draft modified Cadre Review which has been received by the Institute along with its statement was submitted to the Ministry vide the Institute's letter No. NEIGR-Estt-I/99/2014/Vol.III dated 4th May, 2022. After reorganization of existing cadres and considering financial benefit of MACP availed, the financial implication is Rs.46,60,585/- (Rupees Forty six lakhs sixty thousand five hundred eighty five) only per month for the 21 (twenty one) Cadres.

The remaining 32 (Thirty two) cadres who have given various suggestions like upgradation of pay scales, increase of hierarchy of the cadre etc, the Institute is seeking justification with documentary evidence before the proposal is submitted to the Cadre Review Committee.

The Ministry vide letter No. U-12012/33/2019-NE dated 17.05.2023 has requested the Institute to submit a fresh proposal for Cadre Review Group A, B and C Non Faculty posts (one cadre at a time) (Annexure-VIII). In regard to Nursing Cadre (Non Teaching) the Ministry vide letter No. Z-11011/07/2023-NE dated 10.07. 2023 has requested the Institute to submit a consolidated proposal of the cadre re-structuring of Nursing Cadre (Non Teaching) (Annexure-IX).

The Institute is preparing the proposal for all cadres and the same will submit to the Ministry at the earliest.

The Ministry vide Notification No. No. U.12012/23/2017-NE dated 20.11.2017 (Annexure-X) has constituted a Committee for review of Recruitment Rules for all Group A, B and C (Non-faculty)

posts of RIMS, RIPANS and NEIGRIHMS. The final meeting of the Committee was held on 16.11.2022 and the Minutes and consolidated statement after recommendation of the Review Committee on the Recruitment Rules of Group A, B & C Non-Faculty posts in NEIGRIHMS, RIMS & RIPANS has been sent to Ministry vide Institute's letter No. NEIGR-E.III/7/2017/Pt-II dated 06.02.2023 (Annexure-XI). Altogether 56 Nos. of Group A, B and C (Non-Faculty) posts has been submitted after recommendation of the Review Committee. List of posts is at Annexure-XII. Out of these, 29 Nos. of posts have been instructed by the Ministry to upload the draft RRs in the Institute website for 30 days for comments of the stakeholders and thereafter, the comments of the Stakeholders and the Institute are to be submitted again to the Ministry. The draft Recruitment Rules of 19 Nos. of posts of the following cadres have been submitted to Ministry after receiving the comments of the stakeholders alongwith comments of the Institute.

1. Store & Procurement Section
2. Nursing Section
3. Housekeeping Section
4. Statistical Section
5. Dietary unit
6. Central Library Section

The draft Recruitment Rules for 10 (ten) Nos. of posts of the following cadres has been uploaded in the Institute website for comments of all stakeholders and the 30 days period is yet to be over.

1. CSSD Section
2. Administrative Division
3. Accounts Division

The Ministry vide letter F No.U-12012/30/2019-NE dated 26.07.2023 has recently sanctioned 341 (three hundred forty one) posts of Faculty and Non-Faculty posts for the Regional Cancer Centre (RCC). Out of the total sanctioned posts, 66 (sixty six) posts including 55 (fifty five) posts in the Nursing cadre & 11 (eleven) posts in Group B & C will be filled up by promotion. This will also reduce the present stagnation of eligible employees by way of promotion in the respective Cadres.

- (d) Whether, NEIGRIHMS was established at par with AIIMS and PGI Chandigarh if so, its employees have pay parity with such Institutes.

Reply: It is informed that NEIGRIHMS has been designed as a Post Graduate Institute on the lineage of AIIMS, New Delhi and PGIMER, Chandigarh as per the Conceptual Plan approved by the 4th Governing Council meeting of NEIGRIHMS, Shillong held on 29.7.1999 (Annexure-XIII). The Conceptual Plan was prepared by the Institute as directed by the Ministry of Health & FW (Conceptual Plan & EFC copy is enclosed at Annexure-XIV & XV). The Ministry's letter DO No. U.12012/25/2006-NE dated 5.10.2006 stated that NEIGRIHMS was established by the Government on the pattern of AIIMS, New Delhi (Annexure-XVI).

The 12th Governing Council meeting of the Institute held on 26.06.2015 (Annexure-XVII) has approved to maintain pay parity of some posts (like posts of OT Assistants, Technical Assistants etc) with those of AIIMS/PGIMER and took note of proposal for revision of pay scales of Technicians (JLTs & ECG Technicians) as extended to other categories like Store Keeper and Radiographer.

The 14th Governing Council meeting of the Institute held on 10.02.2023 (Annexure-XVIII) has directed the Institute to submit proposals for maintaining pay parity of faculty and staff in line with AIIMS & PGI.

Accordingly, the Institute has submitted the proposal for upgradation of Pay Scale, Learning Resource Allowance and Academic Allowance on the lines of AIIMS and PGIMER, Chandigarh to the Ministry of Health & Family Welfare, Govt of India as incentive to attract and retain faculty members (Annexure-XIX-XXIII).


The proposal for upgradation/revision for the Jr. Lab. Technicians and ECG Technicians has been submitted to the Ministry (Annexure-XXIV-XXVIII) as extended to Store Keepers and Radiographers. The proposal on lines of AIIMS/PGI for upgradation of pay scales (OT Assistants, Technical Assistants etc) and posts (Medical Social Worker to Medical Social Service Officer Gr.I, Physiotherapists to Sr. Physiotherapists etc) have been submitted to the Ministry (Annexure-XXIX-XXXI). The 43rd Standing Finance Committee in its meeting held on 12.06.2023 (Annexure-XXXII) has also considered and recommend the proposal of the Institute for upgradation of pay scales of the posts of Speech Therapist and Audio Metric Technician at par with counterpart at AIIMS, Bhubaneshwar, AIIMS, Jodhpur and AIIMS, Patna. The proposal for the same was submitted by the Institute to Ministry vide letter No. NEIGR-GAD(RC)/06/2023 dated 17.07.2023 (Annexure-XXXIII)



It may be mentioned that 116 (one hundred sixteen) Group C & D posts in NEIGRIHMS have been abolished by Ministry with an instruction that if required these posts may be filled on outsource basis following the guidelines provide in MoA, Rules and Bye-Laws of the Institute and also following the guidelines of DFPR and GFR. At present the Institute is outsourcing manpower services of Group C & D posts from outside agency.
3. As the Group C posts perform operative tasks, render clerical assistances and carry out routine duties, the permanent Group C employees are required for career progression as these employees can be promoted to higher levels of administrative positions.


